- 1. Add resources to increase specialists in all LBPSB schools.
- 2. Increase the material and human resources in the school libraries.
- 3. Offer board-wide professional development on conflict resolution, including a speaker to address both the teacher and parent communities.

We thank you for giving us the opportunity to provide our recommendations for this important process.

#### Suggestions regarding the allocation of funds:

- 1. Allocation of funds towards mental health support for students. Increased allocation for Integration Aides, Resource departments, and Board-Level Support (Psychologists, SLP's, OT's, PT's, etc.). Access to mental health support outside of school is extremely difficult to come by, even within the private sector, and waitlists are very long. Many families are facing ongoing financial difficulties and cannot afford to access services. The repercussions of these mental health issues are far reaching and affect the student's ability to learn and thrive all the while contributing to behavioral issues. LBPSB's commitment to offering safe and caring schools must extend to helping students deal with mental health challenges.
- 2. Allocation of funds towards added support staff in the classroom to acknowledge the growing number of neuro-diverse students and to foster inclusivity.
- 3 .Allocation of funds to professional development for teachers to help them identify the particular needs and learning challenges of special needs students.
- 3. Allocation of funds towards climate change awareness and sustainability projects.

#### Other comments and suggestions:

Understanding that limited budget must be prioritized to maximize benefit, with the realities that surfaced in the recent years: the increase need in teaching trough technology, pandemic after effects on mental health and social skills, creating a diversity and inclusion environment, etc.

Should there, by chance, be an availability of funds to do so, we suggest that the School Board consider updating schools with regards to such items as air quality systems, air conditioning, school furniture such as desks, lockers, etc. LBPSB does a very good job of maintaining current buildings but the contents of these buildings must not be neglected and do have a finite life span.

Do you have any suggestions regarding objectives, principles or criteria used to govern the allocation of funds?

Top 3 issues

- 1. Improve the quality of education for all students by:
  - a. Increasing funding and training for support staff, including, but not limited to, special education technicians, integration aides and behavioral technicians.
  - b. Reducing class size. We are concerned that student codes are not determined in early years which imbalances the weighting of those classes.
  - c. Increasing professional services and support for students who have not yet been evaluated as requiring additional services or support or gifted students, who do not have a code or current allocation. This would include resource teachers, professionals such as psychologists, speech and language pathologists, occupational therapists, ASD consultants.

d. Increasing release time for teachers to participate in meetings to better

support students with additional needs.

2. Increased funding to support the acquisition of the French language is essential.

For example, the Intervention Intensif program or other similar services geared

towards early language development.

3. New funding that would align the board's Environmental and Sustainability policy

with a budget line. Examples of ways this funding would help align policy to

action:

a. greening our schools and land by moving towards renewable energy,

b. planting trees in play areas to reduce the heat islands of pavement,

c. improving insulation in aging buildings.

Other Comments or Suggestions:

As per our request from the past few years, we would like to see how funds are used. Also in the case of surplus how it is distributed. In order to help us consult on these topics we would like to have yearly reporting on the outcomes based on the

consultations that have been made.

We would also like to reiterate, as we have in the past, that as a school that takes the integration of students seriously, the teaching staff needs to be given the proper training and tools to be successful. It is imperative that we get the proper support to reach the goal of giving integrated children what they need to succeed.

### 2-Do you have any suggestions regarding the objectives, principles, or criteria used to govern the allocation of funds?

- 1. Employ more professionals to meet the needs of special needs students consistently throughout the entire school year.
- 2. Increase funding to provide continual francisation programs, and/or des 'class d'accueil' (proven methodology) throughout the year to help struggling students with French.
- 3. Additional funding for French resources, materials and staff to support students that are struggling with French language learning,
- 4. Increase Resource support so that ALL students' needs can be met, particularly those deemed less severe, or not severe enough, yet who still require support to reach their full potential. Hire enough SLPs to meet the needs of students.
- 5. More training opportunities for teaching and school staff (Equity, Diversity, and Inclusion training (EDI), child psychology & behavior management, learning disorders, and autism)

- 6. Continued literacy support for students; diversify program options and provide reading experts and experts in reading disorders to assist students with specific needs Invest in staff training and program development to assure the continuation of literacy programs in future years.
- 7. Mental health and wellness (programming and resources for staff and students) including mental health days for staff and students.
- 8. An environmental fund. Continued monitoring and improvement of indoor air quality. Continued environmental audits for best practices and long-term recommendations for the building.
- 9. Funding to revitalize and make improvements to the senior school yard like natural playground equipment elements like logs, rocks, stumps, tree houses, play structures and places to sit that encourages kids to use their imaginations and appreciate nature (grants available)
- 10. Continue financial support for existing school programs that are successful and appreciated, like arts, sports and music.

#### Response:

We urge the Lester B. School Board to allocate part of the funds it receives from the international students it hosts from Asia to support them within the schools that welcome them and the schools themselves.

Currently, students with minimal to no knowledge of English and even less French are joining classes and are expected to follow the curriculum in all subjects with no resources provided for the school to support them.

Those affected by the situation:

- 1) The international students are not only adapting to a new school with new teachers and peers but also a new home away from their families and all the complexities of a new culture. Secondary 4 and 5 students have the added stress of having ministry exams at the end of the school year.
- 2) The teachers have to find their own resources to support the learning of these students and their integration in the classroom. It has happened that some were not able to ask to go to the washroom without using devices. There are worries about difficulties communicating during emergency situations.
- 3) Time, effort and resources are pulled away from the rest of the students in the classes since there are no additional allocations for the international students that have higher needs.

The message repeatedly given to our students and families is that we are an inclusive and accessible school board and while our policies support that, it is a work in progress. We should be promoting the message that the LBPSB is *actively working towards* that goal and continue investing to achieve it. As such, we believe that any flexible funds available to the board should be put entirely to that objective. As research has shown over and over, when you fill the gaps, when you empower the fringes, every student benefits.

This investment would begin with but not be limited to:

- Increase funding for direct student support services such as:
  - Increase amount of support staff in school
  - Increased resources for teachers supporting student needs ( tech , hardware, adapted materials)
  - o Increased professional development opportunities focused on inclusion
  - Increased support for families (social worker access, guidance for outside complimentary services etc.)
- **REQUIRE** all staff to be trained appropriately in understanding neurodiversity, and support for administrators to keep staff engaged in the process of inclusion.

SNAC wishes to reiterate the importance of clear and consistent communication between all parties, something that is lacking at the school levels. The board needs to invest in a standardized method allowing staff and parents a better opportunity for clear, concise and supportive communication.
