At their June 26th regular meeting, the Council of Commissioners of the Lester B. Pearson School Board approved some administrative assignment changes. They are described in the chart below.

## **OTHER ADMINISTRATIVE DECISIONS**

- The Council of Commissioners approved that Andréanne Bertrand be designated as Person in charge of processing complaints (Complaints Officer) for the Lester B. Pearson School Board effective August 28, 2023.
- 2) The Council of Commissioners approved that a request be made to the Minister of Education to authorize the Lester B. Pearson School Board to adopt a budget for the 2023-2024 school year that provides for a deficit of \$2,765,844, with no accumulated surplus available to reduce the deficit after excluding the net book value of land, this authorization being subject to the specified terms and conditions.
- 3) The Council of Commissioners approved that the Lester B. Pearson School Board's Three-Year Plan of Allocation and Destination of Immovables July 1, 2023 to June 30, 2026 be adopted and that the applicable deeds of establishment be issued or modified accordingly
- 4) The Council of Commissioners approved that Commissioners support and encourage the School Board in considering the Equity, Diversity, Dignity and Inclusion lens to foster collaboration and trusting relationships with its community.

- 5) The Council of Commissioners approved the \$11.30 per student Québec English School Board Association membership fee for the 2023-2024 QESBA financial year which begins on July 1 and that the Council of Commissioners authorize the disbursement of the membership fees as follows: a first instalment in the amount of \$195,009.75, payable by July 31, 2023, representing 75% of the fees based on the number of students registered on September 30, 2022, and a second instalment representing 25% of the fees based on the number of students registered on September 30, 2023.
- 6) The Council of Commissioners approved that the partnership agreement between the Lester B. Pearson School Board and CanaBridge Education Inc., effective July 1, 2023 to June 30, 2029, be approved.
- 7) The Council of Commissioners approved that the partnership agreement between the Lester B. Pearson School Board and Xingmei (Cindy) Zhang, effective July 1, 2023 to June 30, 2029, be approved.
- 8) The Council of Commissioners approved that the consultation document entitled Policy on School Daycare and Lunch Program Services and the consultation document entitled Policy on School and Continuing Education Fees be distributed to the Parent's Committee and all other consultative partners of the School Board during the week of June 26, 2023, with responses to be returned to the Secretariat no later than November 17, 2023, for consideration; and that the final draft of said documents be adopted at the meeting of the Council of Commissioners of November 27, 2023.
- 9) The Council of Commissioners approved that the draft By-law 9 Complaint Process be distributed for consultation to all required parties, as per the Education Act, as well as other consultative partners during the week of June 26, 2023, with responses to be returned to the Secretary General no later than November 17, 2023 for consideration; and that the final version of By-Law 9 be adopted at the meeting of the Council of Commissioners of November 27, 2023, after the legal requirements prescribed in section 392 of the Education Act have been complied with.
- 10) The Council of Commissioners approved that authorization be given that a sports protocol be signed with the Fédération Québécoise de boxe olympique and their mandatary 9195-6110 Québec Inc. (Boxe Frères Grant).
