- 5. The Council of Commissioners approved that the members of Council be mandated to attend schools and centres Governing Board meetings at their invitation in order to provide and receive information related to the school or centre, the Council of Commissioners or the community until the next school elections to be held on November 5, 2028.
- 6. The Council of Commissioners approved that effective November 30, 2024, Me François Hamel be designated as Person in Charge of Ethics and Integrity for the Lester B. Pearson School Board; and LBPSB's Procedure to Facilitate the Disclosures of Wrongdoings be rescinded.
- 7. The Council of Commissioners approved that a sports protocol be signed for the 2024-2025 school year with the Fédération québécoise d'athlétisme and their mandatary Club d'athlétisme St-Laurent Select Inc. as well as with the Fédération du baseball amateur du Québec Inc. and their mandatary Les clubs de baseball Les Marquis Itée.
