LEGAL BASIS

- 1. Sections 174 and 181 of the Education Act allow the Council of Commissioners to delegate powers to the Executive Committee, the Director General, an Assistant Director General, a School Principal or Center Director, any member of the Executive Staff as well as to a Governing Board or to the Resource Allocation Committee.
- 2 Any power which is not delegated by by-law in accordance with these sections of the Education Act remains with the Council of Commissioners.
- 3. The Council of Commissioners cannot delegate the powers where the Council is specifically referred to as the authority to take action or make a decision. In the Education Act, these powers appear at sections 9 to 12, 155, 162, 168, 170, 172, 174, 175, 175.1, 176.1, 179, 186, 193.1 and 200.
- 4. When a person or entity is delegated a power by the Council of Commissioners, the person or entity has the discretion to make the final and complete decision on the delegated matter. The request to someone to execute a decision does not constitute a delegation of power.
- 5. Delegated powers cannot be further delegated to another person or entity.
- 6. As per sections 201 and 202 of the Education Act, the Director General has the power to make decisions regarding the day-to-day management of the activities and resources of the school board. The Council of Commissioners has also delegated to the Director General the powers specified in By-law #2.
- 7. At all times, the delegated powers must be exercised by the person or entity in conformity with the law and the School Board policies, by-laws, procedures or other official documents applicable.

GENERAL PROVISIONS

- 1. The present by-law defines the powers and functions delegated by the Council of Commissioners of the Lester B. Pearson School Board to its Executive Committee.
- 2. The Executive Committee is accountable for the decisions taken in conformity with the present by-law and must render account to Council when requested.
- 3. No decision taken under the present by-law may result in expenditures exceeding the adopted budget.

- 4. The Executive Committee may ask the schools or centres and their Governing Boards for any information or documents necessary to exercise the delegated authority (s. 81 and 218.1 EA).
- 5. The Executive Committee may establish committees, organize consultations and request recommendations or reports in the exercise of the delegated authority.
- 6. Wherever a monetary limit is established under the present by-law, the approval must be provided for any total amount excluding taxes.
